DEAR EXHIBITORS

Our traditional cat show in Celje is approaching and will be held in Hall C of Celje Fair. We cordially invite you to take part in the show. This year, visitors will once again vote for the most charming and their favourite cat, which will receive a special trophy on Sunday. Among the BIS winners, we will also select the Best Cat of the Show, who will receive a special plaque.

SHOW REGULATIONS

VETERINARY REGULATIONS:

All cats must be vaccinated against calicivirus, herpesvirus, and feline panleukopenia.

Cats must be clinically healthy and free of parasites. They must have an electronic microchip and their claws must be trimmed. White cats must also have a veterinary certificate confirming that they can hear. Cats travelling from European Union countries to Slovenia must also be vaccinated against rabies. The validity period of each vaccination must be entered in the pet passport by an authorised veterinarian, and the vaccination must be valid on the day of the show. For cats travelling from third countries (Serbia, Montenegro), a rabies antibody titre test is no longer required! Upon entering the EU, the owner must present the cat for inspection at the designated travellers' point of entry. The competent authority must confirm in English in the last section of the pet passport that the animal has been inspected. If a cat does not meet all the prescribed requirements, the authorised veterinarian will also refuse admission to the show upon inspection at the entrance to the exhibition venue.

IMPORTANT:

Exhibitors participate at their own risk. By registering, they agree to comply with the rules of FIFe and ZFDS and to allow their personal data to be published for the purposes of organising cat shows (results in the media, photographs from the show, invitations and information about upcoming shows). Cats must remain in appropriately equipped cages until the end of the show (curtains, bedding, food, water and litter tray). In the event of non-compliance with this regulation and a possible veterinary inspection, the cat owners themselves are responsible for any violation of the Animal Protection Act. In the event of an unauthorised early departure from the show, all results achieved will be declared invalid.

Cages: 70 × 70 × 70 cm; double cages: 140 × 70 × 70 cm.

Exhibitors may display their cats only in the cages provided by the organiser. Other cages and carriers/boxes are not permitted.

Exhibitors must bring their cats to the judging table themselves, except for BIS.

Exhibitors are kindly asked to bring their own chairs.

The entry fee must also be paid in the event of absence if the cancellation is not submitted by midnight on 11 October.
